How and where to submit the application:

<p>The applicants can submit their applications in person between 9:30 am to 12:30 pm on any working day or use the Courier service (with tracking facility) of their choice to send the application. The applicant must keep the tracking numbers (for return courier as well) with them. The High Commission of India will not accept any responsibility in case the courier is lost/misplaced/damaged or delayed. Fee Payment: Fee can only be paid by Online Bank Transfer or with Debit Card (if the application is submitted in person). For more information on making payment please visit:

Processing Time: Normal processing period is 30 working days from the date of completed application delivered at High Commission.

Notary or Deputy Registrar

▲ Name Change Certificate (if applicable) If Applicant's name is different/changed on Foreign Citizenship Certificate or Foreign Passport from that of the Indian Passport.

In case the applicant is minor (under 18 years) both parents must provide copies of the bio page of their

passports- attested by JP

▲ Affidavit for retention and/travel attested by JP, if the applicant

■ Retained the Indian passport beyond 3 years from the date of acquiring foreign citizenship. ■ And / OR Travelled using Indian passport after acquiring foreign citizenship.
